## **Guide for Developers**

Rent to Own is run by OwnCo Homes Limited, a wholly owned subsidiary of Co-Ownership. It is designed for those who currently can't get a mortgage or Co-Own due to issues such as temporary contracts or no deposit. We assess the applicant's affordability and their potential to purchase a property within 3 years, either through Co-Own or with a full mortgage.

If they meet the criteria then we can purchase a new build property with a maximum purchase price of £165,000 anywhere in Northern Ireland and commence a 3 year tenancy agreement with them. At the end of the tenancy they purchase the property from us and are given a 25% rent rebate to help towards a deposit

## The Rent to Own Process

- Online application
  The Rent to Own applic
  - The Rent to Own application consists of an online application followed by a meeting with a member of our team.
- Decision in Principle (D.I.P)
  Once the applicant has been approved we will issue them with a Decision in Principle outlining their property value limit. This is valid for 3 months.
- Property valuation
  Once the applicant has found a property we will instruct a valuation to be carried out. This is valid for 6 months.
- We purchase the property If the property is suitable we will;
  - Issue an Intent to Buy
  - Pay the booking deposit
  - Instruct solicitors to commence the conveyancing process
- Property completion
  We will liaise with your solicitor during conveyancing.
  The handover will be to us and not the applicant.

Property price	Maximum property value of £165,000.
Location	We will purchase new build houses anywhere in Northern Ireland.
New builds	<ul> <li>The house must have had no previous occupants.</li> <li>The house has to be ready to be occupied now or within 6 months.</li> <li>We only consider a turnkey package.</li> <li>Normally the house must have no extras.</li> <li>The price must include all connection fees for utilities.</li> <li>All roads and sewers serving the property must be bonded or adopted.</li> <li>Any service charges must be reasonable.</li> </ul>

Types of property	Please note that to ensure that purchases are in a variety of locations we will not normally buy more than 20% of the properties in a development and not more than 10 Rent to Own properties in any development.
